Budget Goals 2025-26

- Goals inform the budget; the budget provides resources to realize goals
- Theme of FY26 budget is the prioritization of **Achievement & Opportunity** initiatives:
 - Programs
 - Professional development
 - Equipment, supplies, and services
 - Core mission of the district.
- Maintenance of existing operations and facilities
- Specific items and costs will be shared at 3/12 budget meeting
- "Meta" goal of fiscal stability
- Biggest variables—and challenges—are state and federal aid

As of February 26, 2025

- Budget scenarios range from balanced to ~\$375k shortfall, highly dependent on state aid numbers and federal aid projections
- Finalizing cost projections over the next two weeks
- Building multiple scenarios, including potential worst-case
- Balanced preliminary budget will be presented to the BOE for approval on 3/12/2025
